## Local authority records

## Falkirk Police and Burgh Commissioners Finding Aid

Falkirk Burgh Commissioners were established as a result of the Falkirk Police Act of 1859 and they were also known as Falkirk Police Commissioners. The Burgh Commissioners had responsibility for water supplies, lighting and policing. Their powers were transferred to Falkirk Town Council in 1900.

Falkirk was erected a Burgh of Barony in 1600. It became a Parliamentary Burgh in 1833 and was incorporated in 1900. Local government originated with two other bodies: the Stentmasters and the Feuars. They had no legal powers but they raised levies in the burgh and dealt with maintenance and improvements. Their powers were gradually replaced by the legal powers of Falkirk Town Council from 1833.

Falkirk as a Parliamentary Burgh was able to acquire police powers from 1847 by adopting the Amending Act, 1847, but this opportunity was rejected by the householders in 1848. In 1859 Falkirk adopted the 1850 Police Act which gave the Town Council authority to appoint a Superintendent of Police, take over the water, sanitation, street cleansing, public works and improvements from the Stentmasters and various other powers. In 1873 Falkirk adopted the 1862 General Police and Improvement (Scotland) Act which gave additional powers in lighting, cleansing, improvements and police matters. The Town Council (Scotland) Act of 1900 provided for the incorporation of burghs and was adopted by Falkirk in 1900.
