Falkirk Town Council

Falkirk Town Council was established in 1833 following the Burgh Reform Act of 1833 which created parliamentary burghs and gave the new parliamentary burghs the right to elect town councils and to elect a member of parliament. The Town Council was abolished in 1974 following the Local Government (Scotland) etc Act, 1973, and its powers transferred to Falkirk District Council.

Falkirk Town Council. Falkirk Corporation Redeemable Stock

Falkirk Corporation was formed by Falkirk Town Council in 1895 in order to raise capital to fund utilities.
