# Estate, Family and Personal Papers Finding Aid (A-C)

Falkirk Archives holds the records of a number of local estates, families and individuals. All have a close connection with the area. Some records have been collected as examples of typical local material, such as ration books and school certificates

In this finding aid you will find a list of the records we hold arranged by the name of the estate, family or individual. Each list has a brief introduction to the estate, family or individual, giving some information on their history and their connection with the Falkirk area.

You can also search the collections through the website Collections Browser.

There are leaflets available which give an introduction to the sources in the Archives for the study of local industrial history, local social history and family history. There are also a number of educational topic source lists which can be consulted by researchers.

#### James Aitchison personal papers

Rev. James Aitchison was minister of Erskine Church, 1875-1930. During that time Erskine Church was a congregation in three different denominations: United Presbyterian until 1900, then United Free until 1929 and Church of Scotland from 1929. He was educated in Glasgow and Edinburgh, and trained and worked as a watch and clockmaker from 1859 to 1866 before turning to the ministry. He was the author of poems, lectures and sermons published in book and periodical form.

Alexander Aitken (d 1812) was a Mariner from Bo'ness. He owned properties in the town. After his death there was a dispute over his estate among his heirs relating to Settlement he had drawn up but which had no legal recognition.

#### **Burns family papers**

The Burns family of Falkirk originated in Bo'ness where John Burns senior was a customs collector. His eldest son, John Burns studied law at Edinburgh University and became a lawyer in Falkirk in the 1790s. He was one of the first elders of the Free Church of Scotland in Falkirk. Other sons of John Burns of Bo'ness became ministers of the Church of Scotland and later the Free Church of Scotland. Grandsons included ministers, lawyers and a singer (John Robert Burns who studied in Italy despite parental disapproval).

The extended family included Rev Robert Burns, secretary of the Glasgow Colonial Society and a formative influence in the foundation of the Free Church in North America. #### **Cadell Family Papers**

Along with his father, also William, William Cadell junior (1737-1819) was an original partner in Carron Co. At the age of 23 he was appointed manager of Carron Co., a post he held for 9 years. He built Carron Park in 1763 and 4 years later bought the estate of Banton. In 1773 he and his brother John purchased a lease in the Grange coalfield and saltworks. These, along with other local coal companies they had leased, were to be managed under the name of Grange Coal Co.
