Also includes Bond & Disposition by the Hon Sir James Stuart of Lochcarron to Mrs Forbes's trustees and Inventory of the title deeds of the estate of Lochcarron and others in the County of Ross belonging to the Hon Sir John Stuart Vice Chancellor of the Court of Chancery
