## Forbes of Callendar Papers finding aid Part 8 – Papers on Stirlingshire administration

This collection consists of 36m of records from 1531-1974. The records have been arranged into twenty eight series (see introduction for details) and the finding aid has been separated into these series to make it easier to download from our website

Part 8 contains papers relating to the local administration of and communications within the county of Stirling. The papers include information about canals, roads, railways, commissioners of supply, heritors, local defence, police, and schools. The papers were accumulated as a result of the activities of the first William Forbes concerning the development of the canals and local roads, and the work of the second William Forbes as MP for Stirlingshire.
