### Forbes of Callendar Papers finding aid Part 15 – Financial papers of Trustees and others

This collection consists of 36m of records from 1531-1974. The records have been arranged into twenty eight series (see introduction for details) and the finding aid has been separated into these series to make it easier to download from our website.

Part 15 contains financial papers of the Trustees of the second William Forbes and his descendants, 1774-1861.

A727.3864	25 Jul 1821 – 29 Nov 1838	Ledger account book of Thomas Aitken, junior, writer, Falkirk. Includes account due by William Forbes of Callendar in respect of election expenses.

A727.3872	20 May 1827 -5 Mar 1834	Waste-book of Thomas Aitken junior, writer, Falkirk.
A727.3873	1827-1828	Accounts due by William Forbes of Callendar while in Paris [France]. Receipt by his servant of his wages in Milan [Italy]. (13 items)
A727.3874	May – Dec 1829	Accounts and receipts, being vouchers of the personal expenses of William Forbes of Callendar in London, Edinburgh and Falkirk, particularly for his horses. (65 items)
