Forbes of Callendar Papers finding aid Part 20 – Sanquhar Estates legal papers

This collection consists of 36m of records from 1531-1974. The records have been arranged into twenty eight series (see introduction for details) and the finding aid has been separated into these series to make it easier to download from our website.

Part 20 contains legal papers relating to the estate of Sanquhar in the sheriffdom of Ayr.

- A727.4157 1802-1806 Decreet of adjudication in favour of John Innes WS against Joseph Robertson, in London, of subjects to which he is entitled as a creditor of Sir Thomas Wallace-Dunlop of Craigie. Extract disposition and assignation by Innes to William Forbes of Callendar for part of price of barony of Sanquhar. Similar disposition and assignation by Hugh Baillie of Newfield to Forbes. (3 items)
- A727.4158 1824 Petition to sheriff depute of Ayrshire by various heritors for a division of the parish church of St Quivox (St Evox).
- A727.4159 1829-1832 Papers concerning title deeds, feus and rentals of Forbes properties in Ayrshire. (14 items)
- A727.4160 1833 Draft assignation by William Forbes of Callendar to his mother of the rents of lands of Sanquhar and others in Ayrshire.
