Russel & Aitken Papers finding aid (4): Particulars of Estates

The finding aid for the Russel & Aitken Papers has been divided into 63 parts. This part contains a list of particulars of estates collected by Russel & Aitken.

Family/business history

The series of Particulars of Estates were collected mainly by James Aitken of Darroch, (b 1834) writer and solicitor in Falkirk. He succeeded his father, Henry as proprietor of Darroch and as a partner in Russel & Aitken from 1862-1911. He was also a mineral proprietor and farmer. His main leisure interest was shooting and collected particulars of shootings and estates to let all over Scotland.

Scope & Contents Note

This series consists of particulars of estates, plans and correspondence for estates and farms in the Falkirk area. These contain details of extent of the estate, any mineral rights or other rights, and incumbrances on the estate, such as feu duties and casualties, and the annual rental value of the land and property. The plans often include an illustration of the principal residence on the estate. There is also one 20th century estate particular, collected by the firm.

Related Archives

Particulars of estates and farms outwith Falkirk area were transferred to the appropriate local authority archives.

The personal papers of James Aitken are listed in part 7 of the Russel & Aitken finding aid.
