Russel & Aitken Papers finding aid (7) : Papers of Aitken family, 1707-1931

The finding aid for the Russel & Aitken Papers has been divided into 63 parts. This part contains a list of records relating to the Aitken family.

Family history

Three generations of the Aitken family were founders and partners in the firm of Russel & Aitken. The firm acted for most members of the family in their various legal transactions.

James Aitken, (c.1778-1818) a writer and practising solicitor in Falkirk from at least 1792 was the son of Henry Aitken and Elizabeth Scrimgeour, and the grandson of William Aitken a tenant in Calham (Callium), and his wife Elizabeth Blucle. He married Janet Walker (d. 8 Aug 1841) and with her had three children: Henry Aitken, James Walker Aitken (d aged 24) and Robert Walker Aitken. After James Aitken's death in 1818. James Russel, his apprentice, took over the business. He was shortly joined in partnership by Henry Aitken of Darroch (c 1800-1860), and the partnership thereafter became known as Russel & Aitken.

Henry Aitken of Darroch also had interests in mining and property. He married Margaret Russel, (d. 1860) daughter of his partner, James Russel, and with her had eight children : James, Russel, Henry, John (a climatologist), Robert, Jessie, Catherine (d. 15 Jan 1838 aged 18 months) and Walker (a Major in the army).

James Aitken of Darroch, (b 1834) writer and solicitor in Falkirk, was one of eight children of Henry Aitken of Darroch and the grandson of James Aitken of the firm of solicitors in Falkirk. He succeeded his father, Henry as proprieter of Darroch and as a partner in Russel & Aitken from 1862-1911. He also took over his father's interests in mining and properties. His main leisure interest was shooting and one of his habits was to apply for particulars of shootings and estates to let all over Scotland. He was a Lieutenant in the Falkirk Company of the Stirlingshire Volunteer Rifle Corps. He also belonged to Stirling Golf club and East Stirlingshire Cricket Club.

The other children on Henry Aitken of Darroch included Dr John Aitken LID; FRS; FRSE (1839-1919) of Ardenlea, Falkirk, who was a physicist and climatologist. He was awarded the royal medal by the Royal Society of London, in 1917. Jessie Aitken took over the estate of Glenbervie after the death of their brother, James. A Curator was appointed for her in 1922 and she died in 1923 aged 80.

Scope & Contents Note

This collection consists of papers of members of the Aitken family - mainly of James Aitken, his son Henry Aitken of Darroch, and grandchildren James Aitken of Darroch, Dr. John Aitken and Jessie Aitken of Glenbervie. It includes executry and trust papers of various family members; progression of titles for Mungal & Merchistonhall and also tracings of plans for football ground pavilion, Merchistonhall Chartulary (including progress of writs from 1712), papers relating to property in Bennetstown and Cow Wynd, Falkirk; correspondence and papers relating to maintenance of Glenbervie estate, papers relating to Lands of Lodge, Slammanan including titles, the beginning of an arbitration, reports and plans of coal workings, collier houses and repairs; accounts, vouchers and receipts for household expenses of James Aitken of Darroch; personal papers of Dr John Aitken, Russel Aitken & Walker Aitken, papers relating to mining interests of Henry Aitken of Darroch and James Aitken of Darroch. There is also a recent biography of Dr John Aitken (1998).

Note on arrangement

The records have been arranged into the following series:

- Aitken family executry and trust papers,
- records relating to the mining and business interests of Henry Aitken of Darroch, continued by his son James Aitken of Darroch,
- records of Aitken family properties and related litigation, including Mungal & Merchiston, and Glenbervie
- personal papers of James Aitken of Darroch, Jessie Aitken of Glenbervie and John Aitken of Ardenlea

It is not always possible to distinguish the private records of the partners of Russel and Aitken, the business records and those records where partners are acting together as private individuals, and some of the papers relating to property and litigation may be records of the business rather than of Henry or James Aitken.

Mungal and Merchiston Estates

The owners of Merchistonhall and Mungalhall have included Ramsay, Napier, Joseph Stainton and James Aitken of Darroch. Subjects were important for sewage and water supply for Falkirk. They were close to the Canal and Carron and other foundries. For the last few decades the subjects or a good part of them have been owned by the Steel family. In 1815, Joseph Stainton of Biggarshiels (Manager for Carron Co) bought the superiority of Merchiston Hall from the Trustees of the late Captain Charles Napier Trust. A year later Stainton bought the superiority of four of the five farms on the Nether Mungal part of that Estate: Langdale, Broomyknow, Lethandy and Mungall Mill and the superiority of many of the feus of the private houses in Main St, Bainsford. In 1889, James Aitken of Darroch acquired the superiority of Merchiston Hall and its grounds plus parts of Mungal Estate which Joseph Stainton of Biggarshiels had owned.
