Russel & Aitken Papers finding aid (11) Papers of the Fulton family, 1801-1875

The finding aid for the Russel & Aitken Papers has been divided into 63 parts. This part contains a list of records relating to the Fulton family who were clients of Russel & Aitken.

Family history

William Fulton was born in 1775, the son of Robert Fulton and Elizabeth Rutherford and the brother of James Fulton. He was a candle maker and soap maker. He lived at Sunnyside Camelon and owned land around lock 16, Camelon, Grahamston and in Hutcheson St, Glasgow. William married Euphemia and their children died in infancy. He married again much later in life in 1847 to Janet Shaw of Upper Thomastown. They had one child Jane or Jessie born 1850. She married John Stoddart Robertson, a land agent. William Fulton was one of Allan Glen's trustees. His brother James was born at Auchterarder and farmed at Burnhouse in Falkirk. He married Sally (or Sarah) Gardner in 1816, and their daughter Jane was born in 1816.

Scope & Contents Note

Papers relating to William Fulton and his family including executry papers, minutes of trustees meetings, factorial ages for properties, vouchers, invoices in connection with his daughter, Jessie's education and her clothes purchases, papers relating to her marriage and papers relating to James Fulton of Burnhouse. Also inventory of grates and household effects.
