## Russel & Aitken Papers (19) Papers of the Sword and Brock families, 1693 -1871

The finding aid for the Russel & Aitken Papers has been divided into 63 parts. This part contains a list of records relating to the Sword family who were clients of Russel & Aitken.

## Family history

The Sword and Brock families became linked through the marriages of Isabella Risk, who first married James Brock in 1793 and then Andrew Sword in 1819.

John Brock became owner or tenant of the Crown Inn at the west end of the High St in Falkirk in 1763. This property along with lands at Weitlands (which was near the Bleachfield in Falkirk) eventually passed to James Brock who married Isabella Risk in 1793. He died in 1812.

The Sword (or Sworde) family was known in Falkirk from the mid 17th century and gave its name to Sword's Wynd. Alexander Sword owned subjects in Mungall as early as 1783. Andrew Sword of Mungalhead, (most likely Alexander Sword's son) a farmer and brewer married Isabella Risk, widow of James Brock, in 1819. He predeceased her, dying intestate without issue. She then built Brockville House in 1832, on the lands of Weitlands, and lived there until her death in 1840. Her niece, Marion Risk inherited Brockville House in liferent and lived there until 1870.

Andrew Sword's nephew, Rev Thomas Sword was vicar of Bungay, Suffolk and then later Rector of St Peters, Thetford, Norfolk. He conveyed his subjects in Bainsford to his Uncle, Andrew Sword in 1814. After the death of Andrew Sword, the land was re-conveyed to Reverend Thomas Sword. Upon the death of his grandfather, Alexander Sword of Mungall, Rev Thomas inherited considerable property.

## Scope & Contents Note

Titles and papers relating to ownership of lands in Mungal, Weitlands and the Crown Inn, Falkirk. Details of Andrew Sworde's brewing and farm business, 1819-1832. Papers relating to Isabella Sword's executry and her Trust including those relating to letting of the Crown Inn, and accounts current with Russel & Aitken. Correspondence and settlement of claim against the Edinburgh & Glasgow Railway Co after severance at Brockville House.
