# Russel & Aitken Papers finding aid (21) Papers of Scott family of Jawcraig, 1742-1883

The finding aid for the Russel & Aitken Papers has been divided into 63 parts. This part contains a list of records relating to the Scott family of Jawcraig

### Family history

William Scott snr of Jawcraig was a coal master. He inherited the lands and minerals of Jawcraig, along with the farm of Dyke, Slamannan, from his father, William who had inherited them from his father Walter Scott, the original purchaser of Jawcraig in 1819. William Scott snr of Jawcraig married Bethia Brown and is known to have had at least three sons, William jnr, Henry and Thomas.

William Scott snr of Jawcraig and his eldest son William Scott jnr of Southfield, went into partnership as William Scott & Son, running Jawcraig Colliery.

Bethia Scott inherited Magiscroft in Lanarkshire under and entailment by her grandfather, William Shaw.

On 25 March 1819 William Scott, son of Walter Scott, wrote a Disposition & Settlement of all his heritable and moveable estates in favour of his only lawful son, William Scott (senior). This was recorded in the Sheriff Court Books of Stirlingshire on 2 December 1825.
