Russel & Aitken Papers finding aid (22) Papers of the Russell family of Greenhill, Slamannan, 1652-1902

The finding aid for the Russel & Aitken Papers has been divided into 63 parts. This part contains a list of records relating to the Russell family of Greenhill, Slamannan

Family history

The Russell family association with Greenhill began in 1759 when a William Russell acquired the property.

His descendant, William Russell inherited Greenhill but lived in Grahams Road, Falkirk. He was married but had no issue. He also owned a house in North Basin Street, Grangemouth. He died in 1860. His brother, Thomas, farmed Greenhill and paid rent to his brother, William, as owner. Thomas died in 1869. Thomas Russell of Greenhill had issue as follows: .Thomas Russell junior; Margaret Russell or Shanks (wife of John Shanks of Wester Jaw); Janet; and Mary.

John, brother of Thomas (senior) and William, spent 40 years in the United States, latterly in Kingston, Ulster County, New York State. He had a successful business career in the United States of America and returned to Scotland (Broompark, Denny) a few years before his death in 1873. He was unmarried. His sister Janet, also unmarried, kept house for John during his stay in the U.S. and returned with him. She died in 1876. John's estate, in Scotland and the U.S, was substantial. He had made his own will with a life interest to Janet. The eventual distribution of his estate caused problems.

Thomas Russell junior who was also a farmer inherited the farm of Easter Greenhill but on account of his debts his estate was sequestrated and he became a farmer in East Kilbride. Thomas, junior, had six children: Margaret, b.1880; Agnes, b.1882; Thomas, b.1884; John, b.1886; Mary, b.1889; and Jeannie, b.1892.
