# Russel & Aitken Papers finding aid (23) Papers of the Cook family, 1671-1922

The finding aid for the Russel & Aitken Papers has been divided into 63 parts. This part contains a list of records relating to the Cook family.

#### Family history

John Cook, a merchant in Falkirk, was born in c.1748. He was a shopkeeper in 1788 and purchased property in Falkirk High Street in 1792.

In 1778 he married Mary Gaff from Polmont who died in 1844. They had seven children: John Cook, the eldest son who was in business with his father and died in 1818; Mary, who married James Rennie of Gowanbank, the owner of Grahamston Mill (see part 24 of the Russel & Aitken finding aid) and who died in 1874; Agnes (who married Robert Wilson, merchant in Glasgow, and who died in 1841); Robert; Margaret; James and Elizabeth, (who died in 1851).

Robert Cook, also a merchant in Falkirk, may have been the brother of John Cook, merchant. He was born on 16 December 1751 and his parents were John Cook and Agnes Taylor. The first record of his activities is in 1781 when he and John Cook were involved in the insurance of a consignment from Riga to Alloa.

Robert Cook married Janet Wood, sister of John Wood, shipbuilder, Port Glasgow, who contracted with Henry Bell for the building of the Comet but died in 1811 before the vessel was completed. Robert Cook and Janet Wood had five children: John; Janet; Robert; Elizabeth (Betsy) and Agnes. He died in 1826, leaving his estate to Elizabeth and Agnes, under a burden of a payment of one fifth to Janet and James Walker.

John (jnr) studied at Glasgow (matriculating in 1792, aged 13) and Edinburgh Universities and in 1795 was apprenticed to Walter Scott WS Edinburgh (father of Sir Walter Scott, novelist and poet). His 1794 matriculation certificate was signed by John Anderson whose bequest founded Anderson's Institution, now the University of Strathclyde.

Janet married James Walker, FRS, civil engineer (1781-1862). He was a native of Falkirk, involved in the design and construction of the London Docks and in the building of 21 Lighthouses. He succeeded Thomas Telford as President of the Institution of Civil Engineers. Janet Cook or Walker died in 1858.

Noting is known of Robert (jnr) beyond the fact that he signed a discharge in favour of his sisters Elizabeth and Agnes following his father's death.

Elizabeth and Agnes were not married and lived together in Western Ave, Grahamston. On the death of the survivor of them their assets passed to the descendants of Janet and James Walker, whose daughters were Margaret (who married William Smythe, Advocate, Methven Castle, later Lrd Methven Senator fo the College of Justice); Agnes (who married Captain, later Admiral, Alexander Boyle of Sundrum, Ayrshire) and Janet (who married Charles Edward Lefroy, Secretary to the Speaker of the House of Commons).

## Scope & Contents Note

Papers relating to John Cook's dealing in shipping; title deeds of John Cook's property in Falkirk, Executry papers of John Cook, Mary Gaff or Cook and Elizabeth Cook; and papers of John Cook's testamentary Trust.

Papers relating to Robert Cook: shipping insurance, correspondence with John Wood, Titles to property in High St; papers relating to John (jnr) apprenticeship; Executry papers of Robert Cook, Elizabeth Cook and Agnes Cook with papers showing succession to the descendants of James Walker FRS and Janet Cook or Walker.
