Russel & Aitken Papers finding aid (26) Papers of the Adam Smith, 1656-1889

The finding aid for the Russel & Aitken Papers has been divided into 59 parts. This part contains a list of records relating to Adam Smith and his Executry Trust.

Family history

Adam Smith was born in about 1815 and brought up in Falkirk. He had two sisters, Catherine and Margaret. His father, Robert Smith was a Brewer / Publican in Baxter's Wynd. The family appears to have had a long connection with Falkirk. He started his career with Russel & Aitken and, with a reference from them, went as a clerk/apprentice to James Bain, Writer in Dunblane. He married Bain's daughter, Isabella and they had a son and three daughters. He established a legal practice in the High Street of Falkirk. Initially he and his family lived in rented accommodation including Carronvale House and Dorrator House. He built or extended a house named Duncarron at Boghead, Denny. He purchased the farms of Wester Seamores, Dumbreck and Drumshanty (in East Dumbartonshire) and Canglour (near Plean), which was part of the estate inherited by Thomas Stuart Smith of Glassingall, who founded the Smith Art Gallery and Museum in Stirling. His aim was to benefit from the proceeds of mineral extraction. He also had other properties in Falkirk, Bo'ness, Grangemouth and Edinburgh. Duncarron was built on the lands of Boghead. For most of his life he was at odds with his close family mostly for financial reasons. He ignored the terms of the Ante-Nuptial Contract keeping his wife short of money. His explanation was that he was building up capital in heritable properties which would benefit his family in the long run. He was pressed in this matter by his wife's solicitors and her brother. He had a long term dispute with his son, John George Cayley Smith who was a London barrister and who raised Court of Session proceedings against him unsuccessfully. The son took the part of his mother and sisters. Adam Smith's two sisters supported him with loans. One of them expressed her "disappointment" after he died.

He was usually at odds with his tenants and there is not much evidence of success with mineral extraction. He was also at odds with the Burgh of Denny against whom he raised Court of Session proceedings about the Burgh's claim for access to a well. There is no evidence of Adam Smith's professional activities other than a comment following his death in 1886 that his business books showed he had not made a profit for the 18 years preceding his death. A petition for his sequestration was raised just before his death. Russel & Aitken acted for him in his final days and in his sequestration and in his executry. His estate was not bankrupt and there was a small residue to divide among his beneficiaries.
