# Russel & Aitken Papers finding aid (30) Papers of the Paterson family, 1826-1906

The finding aid for the Russel & Aitken Papers has been divided into 63 parts. This part contains a list of records relating to the Paterson family of Grahamston.

### Family history

Mr John Paterson and and Mrs Jane or Jean Harrower or Paterson of Carron and thereafter Grahamston owned Campfield which had previously belonged to George Meek and after their deaths a dispute over division of their estate ensued between their Trustees and their heirs, the latter being the children of John Paterson's sisters. Mr and Mrs Paterson's Executors were Rev William Steel, John Drysdale and William Ure.

Mr and Mrs Paterson were beneficiaries in their son's Indian estate. Their son was Captain John Paterson of the East India Company Sea Service. The executors of his estate, which principally consisted of 40,000 rupees, were Rev James Brownlees of Falkirk, John Stuart and George Harrower of Edinburgh.

Papers of Mr & Mrs John Paterson Trust including executry papers, Trust papers such as discharges and documents about division of estate, accounts, plan of Easter Seamores with related title deed and papers relating to Captain John Paterson and his monument in Larbert Churchyard.
