## Russel & Aitken Papers finding aid (31) Papers of Capt John Lorn Trust, 1798-1868

The finding aid for the Russel & Aitken Papers has been divided into 63 parts. This part contains a list of records relating to the Lorn family of Grangemouth.

## Family history

Captain John Lorn, shipowner and merchant, Grangemouth, died in 1821 when his wife Janet (or Jessie) Simpson was only 33. He had presumably been a seagoing Captain but there is no detail of that with the papers. Nor is there direct evidence of his activities as a merchant other than the likelihood of dealing in the cargoes of his own ships. He had considerable interests in several ships including the whaler Juno. He had his roots in the Grangemouth area, probably in the farm of Oxgang where other members of his family are recorded. He also owned heritable properties in Grangemouth and Falkirk and he lent substantial sums on heritable security. He left a significant estate on his death.

He and his wife had two children, John, later Dr. John Lorn and Ann who married Dr. Moir. Mrs Jessie Lorn came from Dunbar from another shipping family, returned there with her children in 1830 and lived there for the rest of her life. The Marriage Contract with Captain Lorn provided for her to receive income on his death. She took an active interest (latterly assisted by her son) in the affairs of the Marriage Contract Trust until her death in 1867.

The family maintained a close friendship with the Russel family until James Russel's death in 1858

## Scope & Contents Note

Some items from before Captain Lorn's death relating to shipping and heritable property. His executry papers. Details of his and the family's heritable interests. Details of the winding up of the family shipping interests and the continuing management of the Marriage Contract Trust until Mrs Lorn's death. Incidental family matters discussed in correspondence.
